

→ **Innovations for the academic year 2018/2019**

► **Contribution Vie Etudiante et de Campus (CVEC) = Tax for student life and campus**

The administrative registration depends on the **prior discharge** of the Contribution Vie Etudiante et de Campus (CVEC) [= Tax for student life and campus].

The CVEC is « *intended to facilitate the reception and the social, health, cultural and sport support towards students and to strengthen preventive actions and the health education set up for them* ».

So the purpose of this CVEC is to facilitate the development of services which can be useful for you in your daily life and in your institution as well as the development of benefits offered by the CROUS of your registration academy.

This CVEC is a **tax**, in opposition to a **contribution** ⇒ unlike a contribution, benefits are not derived on the basis of the discharge of this CVEC which consists in an involvement in the student life policy conducted as well by the registration institution as the CROUS.

The CVEC is **compulsory** and must be **settled every year**, in accordance with the following terms and conditions :

When ?	Before being allowed to process to any administrative registration or reregistration in a higher education institution

Who ?	<p>ALL the students who must be registered in initial training in a higher education institution are SUBJECT TO THE CVEC, including students who benefit from scholarships (<i>French Government's Scholarship Holder, Foreign Government's Scholarship Holder, grants paid by a private organization such as a Foundation...</i>)</p> <p>Exempted students :</p> <ul style="list-style-type: none"> • Scholarship holders on social criteria (scholarships managed by the CROUS) • Refugees-students • Students beneficiaries of subsidiary protection status • Students registered as asylum-seekers and who have the right to remain on the French territory

In case of registration in several trainings in the same academic year, the CVEC is due only upon the 1st registration.

The payment or the justified exemption of the CVEC leads to the issue of a **CERTIFICATE** which is to be provided to the higher education institution in which you will be registered : this certificate is compulsory to complete and validate the administrative registration !
